On a motion by Mr. Bohner, seconded by Ms. Cusick, the Board unanimously approved the minutes of the April 9, 2012 Workshop Meeting (5-0).

#### **ACTION AND DISCUSSION ITEMS**

#### Wastewater Treatment Plant (WTP) Digester Mixer Procurement

Ms. Mandes explained that based on the WTP Energy Audit/Bioenergy Recovery Evaluation Study completed in August 2011, the Board authorized the Design Phase for the Truck Waste Receiving Station & Primary Digesters Mixer Replacement Project at the LCA Wastewater Treatment Plant in December 2011. She stated that the draft tube mixers will be more energy efficient, will increase biogas production, and reduce the amount of biosolids generated saving money on land application. She stated that digester mixers are a long lead time item and to maintain the schedule it was necessary to procure the six 24-inch diameter digester mixers in advance of the construction contract bidding. The current schedule anticipates completion of the installation in the last quarter of 2012. Ms. Mandes stated project consultant, CET/GHD, Inc., has recommended that the Digester Mixer Procurement Contract be awarded to Olympus Technologies, Inc. in the amount of \$289,270. She added that regardless of this project, the mixers were budgeted for replacement in 2012.

On a motion from Mr. Bieber, seconded by Mr. Muller, the Board unanimously approved the Capital Project Authorization for Digester Mixer Procurement in the amount of \$289,270 (5-0).

On a motion from Mr. Muller, seconded by Mr. Bohner, the Board unanimously awarded the contract for the Digester Mixer Procurement to Olympus Technologies, Inc. (5-0).
